


# Paper Preparation Guidelines

To download the paper and extended abstract template, go to SHADG 2024 website using the link: <a href="http://www.coesea.iitkgp.ac.in/shadg24/index.php">http://www.coesea.iitkgp.ac.in/shadg24/index.php</a> and go to submission tab as highlighted in the screenshot below. Use the template as a reference for preparing the conference paper.



**Step 1: Title -** Create a concise and compelling title that reflects the content of the paper. Write a clear and informative abstract that summarizes the paper.



**Step 2: Authors Name and Affiliation** – List the authors' names below the title as shown in the screenshot below. Typically, the primary author is listed first, followed by co-authors. Use the full name format (First Name, Middle Initial, Last Name). Below the author names, include their affiliations (e.g., institutions, companies). Use superscript numbers to link authors to their respective affiliations. Provide the full name and location of the affiliations.

**Step 3: Abstract** - Abstract is as a brief representation of the main content, purpose, and findings of the document. The primary purpose of an abstract is to provide readers with a quick understanding of the paper's subject and its key points without requiring them to read the entire document.

**Step 4: Keywords** - Keywords are specific words or phrases that succinctly describe the main topics, subjects, or themes of a document. Provide three to five keywords.

**Keywords:**  $(3 - 5 \text{ keywords, separate two consecutive keywords with a semi colon ';' in between them, Times New Roman 12 font, Italic)$ 

**Step 5: Introduction -** Provide context for the paper's topic and its significance to the industry. State the research question or problem your paper addresses in elaborate form.

#### 1. Introduction

(Times New Roman 12 font, Regular, 1.15 spacing)

This section should cover the scope and objective of the paper. A research gap should be concisely described based on a short literature survey. The authors should provide problem statements and key contributions and outcomes of the work.

**Step 6: Design/Methodology/Approach -** Explain the methods and tools used for research. Describe data collection, analysis, and any experiments conducted.

**Step 7: Results and Discussion -** Present your findings with clear charts, graphs, or tables. Interpret the results and their implications for the industry.

**Step 8: Conclusions -** Summarize the main points and key findings. Highlight the paper's contributions to the industry.

### 4. Conclusions

(Times New Roman 12 font, Regular, 1.15 spacing)

**Step 9: Acknowledgement** – Write about the funding sources, if any, laboratory where you work, industry settings from where you have collected data, etc.
